

SAF-DEE

MINTY FRESH ACIDIC BOWL CLEANER

DESCRIPTION:

SAF-DEE is a concentrated acidic cleaner that quickly and effectively removes rust, discoloration caused by algae, and alkaline deposits (lime, calcium, scale, etc.) from vertical surfaces.

USDA REGISTERED:

Category C1 - SAF-DEE may be used on all surfaces in inedible processing areas, non-processing areas, and/or exterior surfaces.

TOTAL ACIDITY:

21-22% Phosphoric Acid

FOR USE ON:

Toilet bowls, urinals, shower walls, bed pans, autoclaves, drinking fountains, chrome fixtures, vitreous china, ceramic enamel, stainless steel, copper, bronze, brass, chrome and chrome plate, steam tables, dish washing machines, swimming pools, and many others. **CAUTION:** SAF-DEE is an acid and could have deleterious effects on some surfaces. If there is any doubt as to SAF-DEE's compatibility on a particular surface, check a small inconspicuous area first by allowing a small amount of SAF-DEE to sit on it for a few minutes and then rinsing thoroughly with water. If any discoloration occurs, there is a possibility that some damage to the substrate could occur with further usage; however, SAF-DEE may also be diluted and applied for a shorter period of time with good results, but test first.

APPLICATION:

TOILET BOWLS and URINALS: Use full strength directly on a bowl mop and swab inside of bowl (stubborn stains may require rubbing or a second application). Flush, then pour 2 oz. of SAF-DEE into clean water and with the bowl mop, clean outside seats and outside of fixtures. Rinse thoroughly. **SHOWER STALLS and FIXTURES:** Dilute SAF-DEE with 3 parts of water, apply to surface with sponge or swab, and rinse well with clean water. **CAUTION:** Do not let SAF-DEE remain on any surface longer than 2 minutes, since acids may etch some surfaces if allowed to remain in contact for extended periods of time; a second application may be necessary.
